THE INTEGRATED RURAL COMMUNITY DEVELOPMENT PROGRAMME

Introduction

The Integrated Development Programme (IDP) of the Justice Development and Peace Commission, Ibadan focuses her efforts on programmes that develop the capacities of farmers in agricultural productivity and also facilitates the communities' access to socio-infrastructure facilities. These were done through participatory capacity development, self-help activities, advisory services, networking and collaboration with relevant agencies in the targeted rural, peri-urban and urban areas. The main project of the programme is the Integrated Rural Community Development Project (IRCDP). Other projects include the Catfish Sustainability Project (CSP) and Africa Cassava Agronomy Initiative (ACAI).

Integrated Rural Community Development Programme

The IRCDP worked with 33 farmers' groups in six (6) local governments areas of Oyo and Osun States. These local governments are Ido, Ibarapa North, Ibarapa East, Lagelu LGAs of Oyo State and Ayedaade and Irewole LGAs of Osun State, respectively. The target beneficiaries include men, women and youths, irrespective of tribe and religious affiliation. The project targets 750 farmers engaged in the various agricultural value chains.

Project Goal

Promoting food security and increasing the household income of 750 small holder families in Ibadan Archdiocese through sustainable use of resources.

ACTIVITIES

Group sensitization and mobilization

- Farmers groups in different communities were sensitized and mobilized into the IRCDP. The communities include Igboaje, Alagbonrin, Arikoko, Egbeda and Oosa in Isokan LGAs of Osun State, Ijaye Orile in Akinyele LGA, Ladunni in Lagelu LGA, Araromi and Fedegbo in Ibarapa Central LGA, Egbe Omo and Abidioki in Ibarapa North LGA of Oyo State.
- Capacity building on group strengthening and dynamics were carried out for the newly mobilized groups to ensure unity and sustainability of the groups.

Group growth, capacity development, trainings and experience sharing

- Facilitated ten training (split) sessions on key innovation for selected crops (yam, cowpea, cocoa, tomato and water melon).
- Organized a 2-day training on agro service delivery for apex group.
- Facilitated the annual planning and review meeting at both group, zonal and apex level to develop the action plan for the year 2020.
- Facilitated community health talk on community hygiene, and sensitization on the Covid-19 and steps involved in the prevention and spread of the virus.
- Sensitization talk on climate change, its effects and mitigation strategies in agriculture and agricultural productivity.
- Farmer groups were trained on the six (6) steps in Cassava Weed Management and Best Practices.
- Sensitized farmers on issues of gender mainstreaming, land use and how it affects them.
- The capacities of the farmers' groups at the apex level were built on business management, e-marketing and proposal writing.
- The 12th annual farmers' forum was organized on 1st and 2nd of December, 2020 at JDPC office in Ibadan.
- Facilitated quarterly apex meetings where decisions were taken on agro service delivery and investment activities.
- Reviewed the zones agro-service delivery plan for 2019, and developed an annual action plan for the zones.

Farm visit and advisory services

Farms were visited and farmers were given on-the-field technical advice on production activities for both crop and livestock, best practices such as optimum plant population, disease control, weed management, production and use of Integrated Pest Management (IPM), were promoted among the farmers. Management of existing cocoa plantation, pruning activities to reduce the incidence of black pod diseases in cocoa plantation were also demonstrated. Cocoa/plantain inter-plant, yam mini-set and coppicing of old trees in cocoa plantation.

- Facilitated farmer to farmer extension service on rice production. A farmer from Omi-Adio group built the capacity of farmers in Aiyete zone on rice production.
- Demonstration of mechanical labour saving equipment (weed brusher) was done during farm visit to groups.
- Technical advice was provided on cassava disease management, gap filling in tomatoes and maize, ploughing across the slope and fish pond management.

Information sharing

- Hosted one (1) provincial exchange forum (PEF) where field officers shared experiences, ideas and knowledge.
- Regular agricultural information on weather, good agricultural practices, market information was sent to farmers for proper decision making.
- The department produced and broadcasted both live and recorded programme "Agbedoro" on relevant agricultural initiatives for 26 weeks. The programme was aired on Amuludun FM 99.1FM. Information disseminated during the radio programme include weather matters, farming smart strategies, market prices and information, success stories and other emerging issues.
- Produced a jingle on involvement of youths in Agriculture, the jingle was aired on six (6) radio stations in Ibadan.
- The department attended to 246 radio listeners who came to inquire more about the radio jingle on youth in Agriculture.

Networking and lobby activities

As a result of the training on lobby and advocacy, farmers networked with financial

institution for loan while the programme networked with the research institutes like Nigeria Metrological Agency (NIMET) for weather forecast information, International Institute of Tropical Agriculture (IITA) for technical services, Skretting Nigeria for input supply for the out-of-school youths in Agriculture, Nigeria Incentive-Based Risk Sharing System for Agricultural Lending Office (NIRSAL) for loans to mobilize out-of-school youths; and other private institutions.

Involvement of youths in Agriculture

- Monitored the field activities of youths to ensure compliance to necessary innovation
- Regular test cropping was done by five youths.
- Monitored the activities of in-school young farmers' club.
- Organized the interactive sessions between out-of-school youths in Agriculture and their mentors to discuss progress so far, challenges and the way forward.
- Carried out twelve (12) field visits to out-of-school youth farms for on-the-spot assessment and advisory services.

Promotion of community development initiatives

- Facilitated a 2-day community needs assessment for Oloba and environs.
- Facilitated the formation of community development association in Oloba, Isokan LGAs of Osun State.
- Formation of community development committee for Oloba and environments.
- Development of community development action plan for Oloba and environs in Ayedaade Local Government Area.
- Development and submission of letter of request for a primary health centre for the community of Oloba and environs at the Osun State deputy governor's office and the commissioner for health's office, Ministry of Health, Osogbo.

Networking and collaboration activities

ACAI (African Cassava Agronomy Initiative Project)

- The ACAI project collaborated with IITA to carry out research to develop tools that will increase the availability of appropriate and affordable technologies to sustainably improve cassava

productivity in Nigeria.

- In October 2019, the Integrated Development Program of the Justice Development and Peace Commission collaborated with the ACAI project to disseminate the six steps in cassava weed management for cassava farmers. The techniques involve the use of audio visual in demonstrating the processes involved in the effective control of weeds in cassava farms.
- Forty-nine (49) communities and 2,528 farmers were sensitized on the six steps of cassava weed management (913 males, 1615 females).
- One hundred and twenty-eight (128) farmers adopted the use of the six steps of cassava weed management.

Association of Sustainable Seed Producers of Oyo, Nigeria (ASSPON)

- Producers of certified cassava seeds in Oyo State held one out of the two scheduled bi-annual meeting in Ibadan in August. Major plans were set in motion to ensure that quality certified cassava seeds of preferred varieties are multiplied for next year's planting season.
- Modalities of possible inclusion in GoSeed scheme of International Institute of Tropical Agriculture (IITA) were agreed on as part of the plans for next year in order to fast track sales of certified cassava seeds.
- BASICS-II (Building an Economically Sustainable Integrated Cassava Seed System) project team in IITA held a planning meeting with the seed producers in a bid to sustain commercial cassava seed production in Oyo State and in anticipation of including the association in the activities that will culminate in the formation of a National Cassava Seed Producers' Association in Nigeria in 2021.

Covid-19 Palliative

In response to the challenges created by the pandemic, a non-governmental organization Givefood Nigeria and a seed producer company, Corteva Agriscience partnered with the Integrated Development programme in the distribution of palliative for farmers.

benefitted from the programme - one hundred and twenty (120) beneficiaries under Corteva Agriscience and ninety-seven (97) beneficiaries under Givefood Nigeria.

Results

- Twelve (12) farmers' groups were sensitized and mobilized during the reporting period.
- Twenty-three farmers' capacities in Ayete zone were boosted in rice production. three of the farmers have started growing rice. (one female planted ½ an acre while two males planted 2 acres each)
- Twelve (12) groups comprising 192 members (156 male and 36 female) were reached during the demonstration of the labour saving device equipment (weed brusher). One farmer purchased the equipment for his personal use.
- One (1) Community Development Committee was formed to oversee the community development plan of Oloba community and environs and environs.
- One (1) community development action

plan was developed for Oloba and environs from the community needs assessment.

- The Community Development Committee of Oloba and environs wrote a Letter of request for a primary health post to the Osun State Ministry of Health, Osogbo.
- Based on the previous training on peaceful co-existence, Lanlate zone reached an agreement with local Fulanis on the payment of compensation anytime their cattle invade a farm.
- Ninety-eight (98) students of Onitabo High School and Bioku Grammar school in Lanlate were re-admitted into the in-school youth in agriculture initiative.
- Twelve (12) youths who came as a result of the radio jingle received technical advice in various agricultural enterprises. They are now engaged in both crop and animal production.
- Regular test-cropping of catfish was done by the five youths.
- One youth farmer stocked 1,200

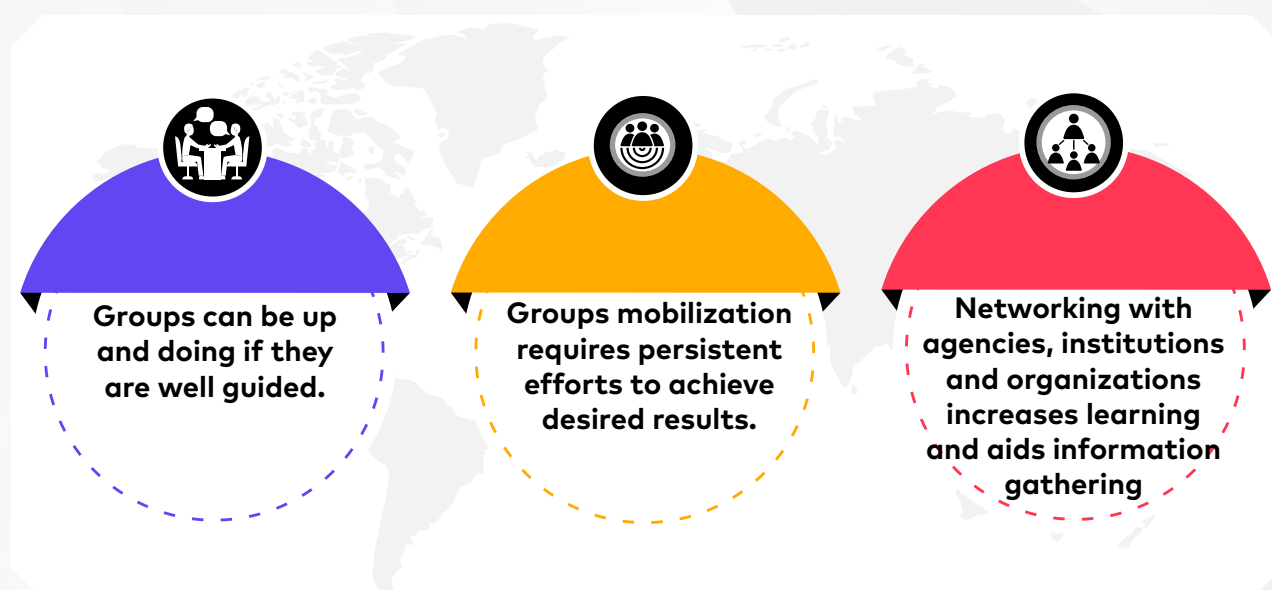
fingerlings into the pond in the second cycle of production.

- Nine (9) youths got involved in agriculture and seven (7) others are currently generating income from agriculture.
- Seven (7) out-of-school youths stocked a total of 10,450 catfish. One (1) youth raised a total of 710 broilers in 4 cycles, while one other is into crop production.
- Construction of one (1) 12" x 12" charcoal cooler at Gbangbagere in Ayete zone to preserve vegetables and fruits to reduce post-harvest losses. It is a model that can be adopted by farmers using available local resources.
- Designed, produced and distributed 5,000 stickers on climate smart strategies.
- Thirty-one (31) farmers' representatives at the apex level gained knowledge on business management, e-marketing and proposal writing.
- Two (2) farmers sent in their business plans for review.

Challenges

- The interstate lockdown and restriction of movement as a result of the outbreak of corona virus (Covid-19) affected field activities and farmers' operations. A lot of farm produce could not be sold and ended up being wasted.
- Prolonged drought and inconsistent rainfall pattern affected crop production during the reporting period.
- Continuous invasion of crop fields by herdsmen and resulting conflicts are becoming a great threat to food security and the programme intervention

Lesson Learnt





CATFISH SUSTAINABILITY PROJECT

The Catfish Sustainability Project is a social intervention for catfish farmers funded by Skretting Nigeria and facilitated by the Justice Development and Peace Commission, Ibadan. The fourth phase of project's implementation commenced from January 2020 and ended in December 2020. The project targeted 700 catfish farmers in both Oyo and Ogun States of Nigeria. (The beneficiaries include 467 previously mobilized catfish farmers and additional 233 newly mobilized catfish farmers). The project provides capacity development for the targeted beneficiaries and a revolving feed input support for willing farmers.

PROJECT GOAL

The aim of the project is to promote income generating opportunities for the small scale fish farmers through a sustainable aquaculture system in an environmentally sound manner.

The specific objectives are:

01



Improve the performance of catfish farmers for increased income

02



Promote best practices to ensure environmental sustainability

03



Enhance stakeholder's participation in catfish production



ACTIVITIES

Group sensitization and mobilization

New catfish farmers' groups were sensitized and mobilized into the project. Meetings were held with the mobilized groups to define roles and responsibilities of the parties and the modus operandi of the project.

Group growth, capacity development and experience sharing

Catfish farmers' capacities were developed in the following areas:

- Best management practices in aquaculture which include: pond preparation and disinfection, fish reception, acclimation, sorting and stocking, feeds and feeding management., test cropping, disease management, water management, etc.
- Group dynamics and strengthening
- Record keeping and use of the farmers Information System (FIS) Logbook
- Cooperative Management
- Savings, Credit and financial management

Meetings, monitoring and advisory services

- The field activities of the catfish farmers were carefully monitored through field visits, regular test cropping and keeping of the necessary records of fish growth. Adherence to the recommended standard practices for catfish production was encouraged among farmers
- Group meetings of farmers were closely monitored for group dynamism. Group decisions were carefully guided to ensure group growth and development
- On-the-farm advisory services were offered to farmers for standard practices for catfish production and higher productivity.
- Weekly project planning and review meeting of the Project officer's meeting on project implementation was carried out to ensure proper planning and implementation of the project.

ACCESS TO REVOLVING FEED INPUT SUPPORT

- Cat fish farmers under the project access the revolving feed input support. The importance of the feed revolving input is to enable catfish farmers adapt to the recommended standard practices for improvement, relief the farmers of the stress in sourcing for feed as well as improve their production income.
- The project team monitored the request and the use of the revolving feed input and facilitated the repayment of the feed input support service through constant monitoring of the beneficiary field and marketing activities..

PARTNERS' MEETING

The partners involved in project implementation (Skretting Nigeria Ltd and JusticeDevelopmentandPeaceCommission) met at the beginning and close of the year to review the project implementation, the results achieved, the challenges encountered and the lessons learnt during the course of project implementation.

OTHERS

- Facilitated the Catfish Sustainable Project groups' chairmen/representative

meeting which deliberated on fish marketing and price.

- Based on identified knowledge gaps, training on Citizen's Right and Civic Education was organized by the project team for a group. The training was facilitated by an officer from the Democracy and Human Rights Programme (DHRP) department of JDPC

RESULTS

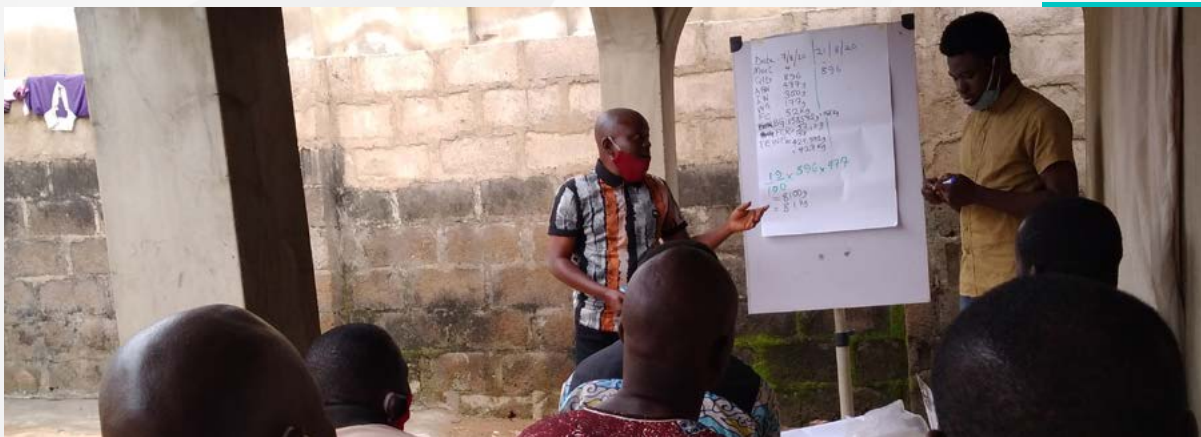
- A total of 175 (One hundred and seventy five) new catfish farmers were mobilized, sensitized and incorporated to participate in the project within Oyo and Ogun states.
- A total of 273,205Kg (273.205 tonnes) of feed has been accessed by four hundred and forty seven (447) participating farmers.
- Capacities of farmers developed are as follows: 119 (One hundred and nineteen) farmers comprising of 105 (one hundred and five) male and 14 (fourteen) female catfish farmers on the Group dynamics and Strengthening. 109 (One hundred and nine) farmers comprising of Ninety four (94) male and Fifteen (15) female catfish farmers on Savings, Credit and financial management. One hundred and fifteen (115) farmers comprising of one hundred and one (101) males and fourteen (14) female catfish farmers on Cooperative Management
- Two (2) groups adopted the point of sale (POS) marketing strategy which reduced exploitation by fish mongers while another five (5) members from two groups adopted neighborhood marketing strategy,
- Eight (8) catfish farmers' groups are practicing savings, credit and thrift as a result a result of the project intervention.
- The farmer-to-farmer extension system adopted by the project has improved farmers relationship and adoption of best management practices pushed by the project team.
- Five (5) catfish farmers' groups are able to take better and informed decision for group and personal development.
- As a result of the group strengthening activities, some group members benefitted from unity and group team

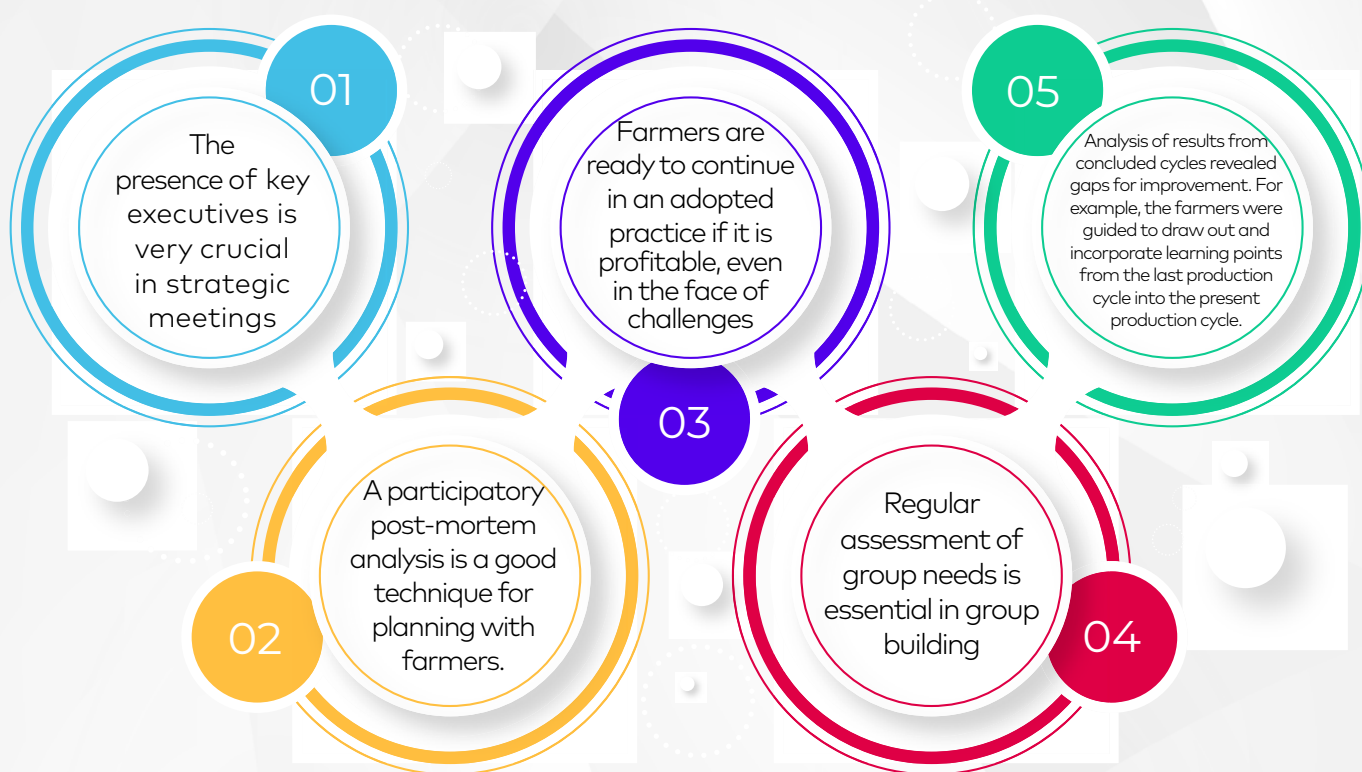

work. For example, in Popo waterside fish farmers group, Ilora, a member benefitted from group unity and teamwork as they were able to track down his stolen fish and overcome undue police craftiness and extortion. In another group, Greenleaf fish farmers' cooperative society, 15 out of 21 members in the group benefitted from the group via credit facilities or other types of support to cope with the covid-19 pandemic.

- The sustainable catfish farmers' chairman forum is now a formidable voice in the determination of the market price for fresh catfish in Ibadan.
- The capacities of sixteen (16) farmers' (10M, 6F) were developed on the legal aspects of (a) Land and property acquisition (b) Citizen relationship with Law Enforcement Officers.

Lesson Learnt



CHALLENGES

- Government restriction due to the Covid-19 pandemic slowed down the implementation projects' activities in the following ways:
 - o Mobilization of new groups was put on hold, because it is an activity that involves gathering of a substantial number of persons, which is not in tune with current Covid-19 guidelines.
 - o Groups could not be visited during the times of restricted movement
 - o When visits are made, only few group members are allowed per time, thereby increasing frequency of pond and group visits.
- o Trainings that should have come in handy for the farmers at the onset of the major production (rainy) season were delayed
- o Repayment of the input support fund was slowed, as offtake of produce was considerably slowed down by the pandemic
- Irregular rainfall patterns delayed stocking cycle for some catfish farmers, while it also forced some farmers into untimely sales.
- Conservative nature of catfish farmers, which has made their adoption of several ideas on multifaceted marketing strategies rather slow.

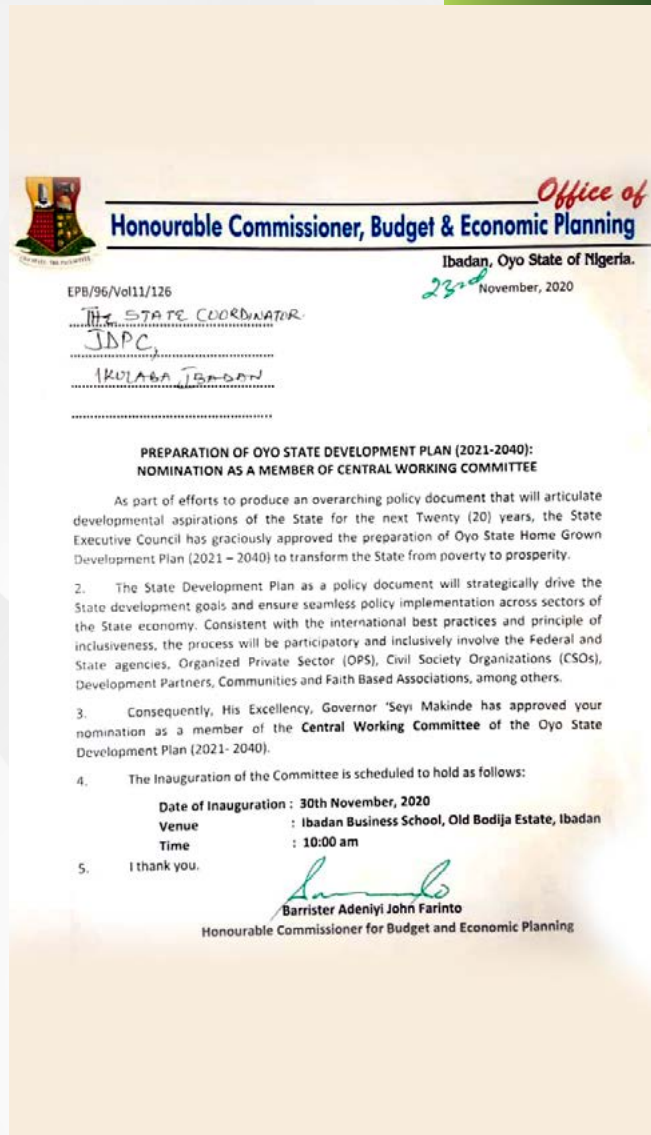

Collaboration with other legal aid providers on the implementation of the Administration of Criminal Justice Law of Oyo State 2016. To achieve this the group made two advocacy visits. We met with the Controller Correctional Services on the need to use the new Custodial Center at Olomi, which is bigger so as to reduce the congestion in Agodi Custodial 3.Center. He was able to let us into the challenges of moving and how stakeholders can intervene.

The group also visited the Chief Judge to discuss the need for introduction of technology in court proceedings to speed up the prosecution of cases. The CJ welcomed the idea and he put the process in place for the actualization of this idea to be driven by Citizens' Gavel.

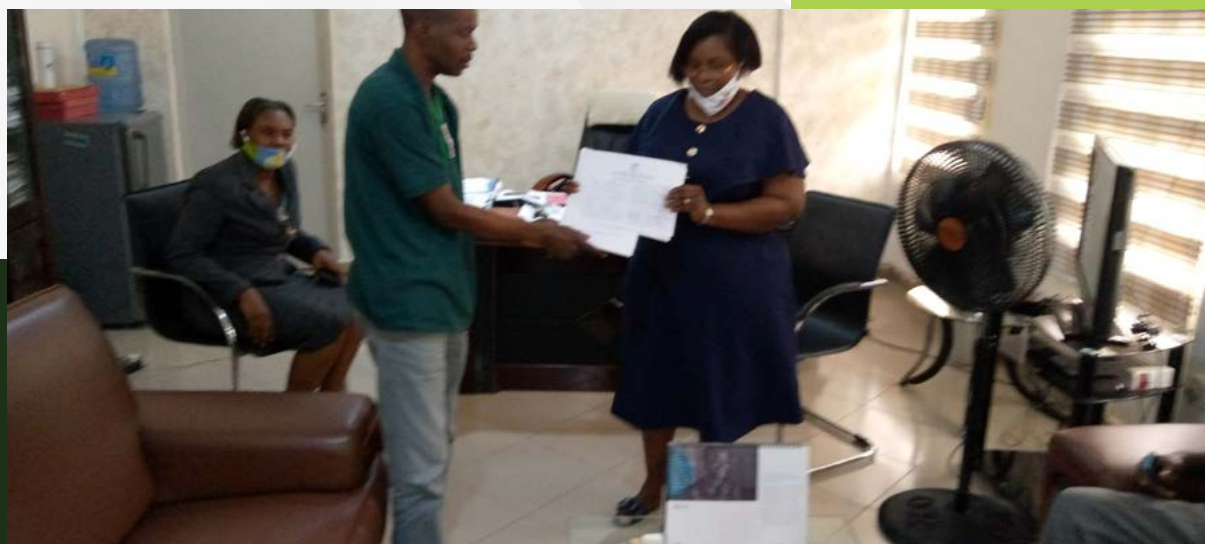
In order to ensure that the input of the citizens in the budget of the state is actualized the project team along with some members of the civil society paid advocacy visit to the management team of Ministry of Budget and Economic Planning on the Feedback on Citizens inputs into 2020 Budget and on the planned review of 2020 Budget of the Oyo State.

The Management disclosed that Feedback desk with dedicated phone line and personnel will soon be in operation for Citizens feedback on 2020 budget performance.

*They revealed that the citizen' inputs were categorized into three major areas with different level of government responsible. According to them, there are some that falls under local government jurisdiction; some under Constituency project of the lawmakers while the state handled the remaining.

*They further disclosed that most of the projects were road rehabilitation and government would soon commence the mass rehabilitation of road through Oyo State Road Maintenance Agency.

The Management also assured that budgetary allocation for sectors will be made available to the citizens for monitoring.

During the year the team attended the inaugural meeting on Local Study by Senior Executive Course (SEC) No. 42, 2020 organised by National Institute of Policy and Strategic Study (NIPSS); KURU.

After the meeting we were taken through local study tour of Population Growth and Human Capital Development in Nigeria: Challenges, Issues and Prospects from CSOs perspective.

-We were aware of the theme of the study tour titled: "Population Growth and Human Capital Development in Nigeria: Challenge and Prospects".

- We presented a paper titled: 'Population Growth and Human Capacity Development in Oyo State and the effects on CSOs activities in the Oyo State' where the participants were sensitized on the issues related to this.

Attended Virtual meeting on the review Of 2020 State government budget along with the leadership of CCGG and CDC at the JDPC

Facilitated CSOs and Community Development Groups (CBOs and CDCs) and participated in Town Hall meeting on 2021 Budget.

The Citizen Groups interacted with the Commissioners for Finance, Budget and Economic Planning on their priority area. The members of the group used the opportunity to submit proposals which are mostly in the area of: Health care services, Education and Water and sanitation considering the current Covid-19 pandemic in the State.

*We were able to mobilise Educare Trust, FOWAN, CCGG and CDCs members for the meeting. This cut across Ibadan N, Ibadan S/E, Ibadan S/W, Egbeda, Ona-Ara, Iddo. Others are Oluyole, Akinyele, Ibadan N/E and Ibarapa. The mobilised groups were able to present their community needs for the government to mainstream into the 2021 Budget.

We participated in the budget tracking on allocation of N100m budget allocation for the purchase of equipment, motorcycle, Mobile Clinic in Ibadan S/E, Ibadan N/E and Ibarapa East LGAs in the 2019 federal government budget.

Visited Ibadan S/E and Ibadan N/E to ascertain the availability of health equipment, Mobile Clinic and motorcycle. We discovered that none of all these have been implemented and the result of the finding has been forward to our partner IBP for further engagement.

MONITORING CCGG AT THEIR MEETINGS

The animated group of the organization the Civil Coalition for Good Governance (CCGG) were monitored and strengthened to function effectively at the community level.

Had a review meeting with CCGG/CDC leaders in ten local government areas of the Archdiocese of Ibadan to review their activities in the last three years, findings of evaluators concerning JDPC animated group; CCGG and our focus for the next three years.

Facilitated the 8th annual Congress of the civil coalition for Good governance with 96 delegates in attendance from eleven local government areas within the Archdiocese.

From the technical backstopping given through the year the members of the CCGG were able to facilitate 4 projects for the improvement of their various communities. Some of the achievements made are:

- *Engaged the State Universal Based Education Board (SUBEB) on inadequate teachers experienced in the Basic Schools in Ibadan N/E.
- *Transformed a manual borehole to an electronic pumping machine for the community in Ibadan NE.
- *Requested for a new transformer from the Ibadan North/East; which was granted and has been restored for use by the community in Ibadan NE.
- *Advocacy visit was made to UCH to engage the management on the equipment installation at the new PHCC Oke-Apon.

96 delegates engaged the management of State Independent Electoral Commission on the plan for conducting free, fair and Credible polls.

OSIEC team also promised to involve CCGG team at local and communities levels across state in mobilisation and sensitization of eligible voters to ensure good turn out during the polls.

DIALOGUE WITH HEADS OF GOVERNMENT AGENCIES ON POLICY FORMATION AND OBSERVED OYO STATE HOUSE ASSEMBLY

Observed the State House of Assembly
 *Attended public hearing at the State House of Assembly

Contributed to 4 bills before the House. These are:

- Oyo State Security Network Agency Bill, 2020; 'Amotekun Corp'
- Oyo State Sexual and gender based violence-response team referral centre Bill, 2020
- Establishment of the office of Public Defender Bill, 2020
- Violence against persons (Prohibition) Bill, 2019

Engaged with the Commissioner of Environment Rt. Hon. Kehinde Ayoola on the need to dredge some rivers in the State in order to avoid flood in the fort coming raining season.

The following rivers were dredge from the list of the rivers submitted to the Hon. Commissioner; Rt. Hon. Kehinde Ayoola. These are: Odo Omi, Odo Oba and Odo Ahere respectively.

We forwarded our research work in the area to Women Development Programme (WDP) and Child's Rights as an eye opener towards the proposed policy.

These are in the following areas:

- to confirm the number of peoples' needs mainstreamed into the State Budget for the fiscal year 2020 in the course of consulting with the people at the grassroots for their needs for the 2021 Budget.
- On the State Mid-Term Strategic Framework for the State (MTSF).

- Also on the State Development Plan (SDP) together with Medium Term Expenditure Framework (MTEF) and Medium Term Sectorial Strategy (MTSS). JDPC was appointed into the Central Working Committee and saddle with the responsibilities to review the report of Technical Working Committee.

Participated in the virtual Launch of the Public Budgeting App by PERL/DFID in Abuja with **Federal** and **State** government actors.

 *State actors in attendance also promised to make their information available on the app.

One advocacy visit to the Chairman and two to the Executive Secretary State Primary Health Care Development Agency.

WOMEN DEVELOPMENT AND CHILD'S RIGHTS PROGRAMME

Introduction

The Women Development and Child's Rights Programme (WDP) of Justice, Development and Peace Commission, Ibadan made giant strides in the year 2020, despite the Corona virus outbreak, towards the protection and promotion of the human rights of children and vulnerable women. It is the focus of WDP to address the sufferings of children and women in terms of various forms of abuse, exploitation, violence and neglect. The Programme engaged in deliberate methods and actions to reduce such unpleasant situations as sexual molestation, female genital mutilation, child hawking and other forms of child labour, the problem of out-of-school children, maltreatment and severe beating of children, child neglect and violence against the children and women. The humanitarian and development actions of Women Development and Child's Rights Programme in the year covered areas of the Catholic Archdiocese of Ibadan; that is, Oyo State and some parts of Osun State, Nigeria.

In 2020, the focal activities of WDP include the following:

- 

Facilitate the enforcement of the Child Rights Act for the reduction of incidences of child trafficking, labour and violence in our immediate environment.
- 

Create public enlightenment on the dangers of FGM and facilitate opportunities and access to expert counselling for FGM survivors.
- 

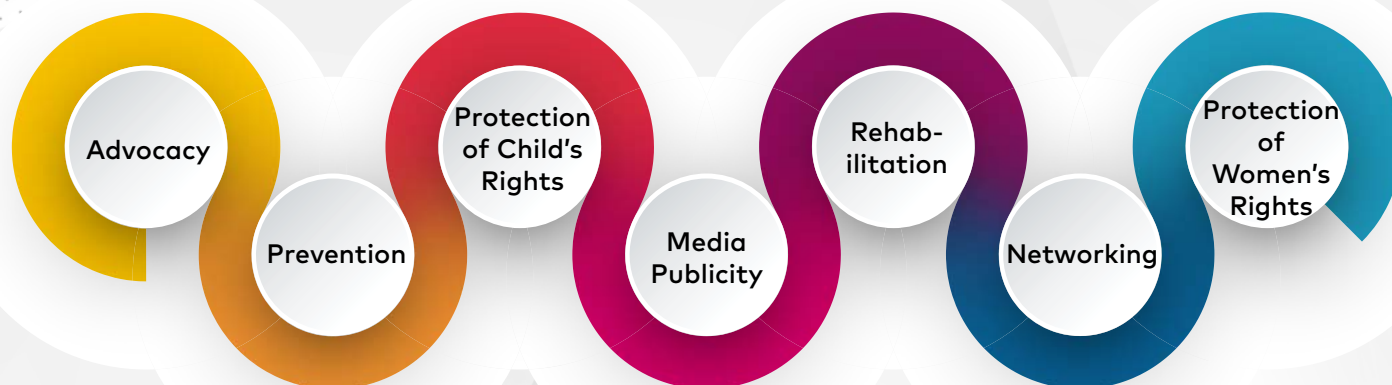
Facilitate positive orientation of children on their rights and their active participation towards protection and promotion.
- 

Network and collaborate with partners in relevant fields to facilitate, contribute and enhance the chances of success in our projects' implementation.

In the year 2020, WDP recorded laudable achievements in providing economic empowerment support for the households of indigent children, follow-up on the children beneficiaries of educational and vocational support, capacity development of parents, teachers and children as well as other stakeholders on child's rights, counselling support and casework interventions for affected children who are indigent, vulnerable or abused as well as women and their households in order to achieve more robust positive outcomes.

METHODS OF ACTION

Methods of action in addressing the problems affecting the human rights and development of children and women in the year essentially include:



ACHIEVEMENTS

ADVOCACY

- The Women Development and Child's Rights Programme as usual engaged in advocacy visits to key stakeholders and influencers on child protection and promotion in the year 2020. Advocacy in the Programme remains continuous for strengthening collaboration and positive influences on child protection in Ibadan and Oyo State at large. The Programme in collaboration with the Child Protection Network of Oyo State visited the Olubadan of Ibadanland on 10th November in commemoration of the 19 Days of Activism to Prevent Violence against Children. In the year 2020 a notable outcome of our advocacy visits and collaborative efforts is the official inauguration of the Family Court in Ibadan, Oyo State on 9th July. Furthermore, advocacy activities in the year helped to achieve coordinated supports of stakeholders in addressing problems relating to violations of human rights of children and women in Ibadan and its environs.

PREVENTION

Women Development and Child's Rights Programme in 2020 carried out enlightenment activities with focus on children and women's rights so as to prevent cases of human rights violations affecting children and women in our immediate environment. Some of these enlightenment activities for preventive purposes include the followings:

- Enlightenment talks on child's rights issues with attention to the roles of children in the protection and promotion of their rights for members of the established School Based Child's Rights Club at Ijokodo High School, Ibadan on 29th January. Also, in commemoration of the World Children's Day which is celebrated annually on 20th November to promote international togetherness, awareness of children and welfare of children, the Programme carried out enlightenment talks for children at Loyola College, Ibadan and Community High School, Airport, Ibadan. One hundred and fifty children participated in the enlightenment talk at Loyola College Ibadan and 115 children participated at Community High School, Airport.
- A public rally was held in Oluyole LGA on 19th March to sensitize the public at Olomi and Muslim areas in Ibadan on child's rights issues. The rally was implemented in collaboration with the Network for the Defence of Child's Rights including Anti-Human Trafficking Units of Nigeria Immigration Service, Ministry of Education, Ministry of Women Affairs, Ministry of Information, Ministry of Justice, Ministry of Labour and Productivity, Oyo State Teaching Service Commission, Nigeria Civil Defence Corps, Nigeria Police, Community/Religious Leaders and many other child's rights organizations and groups.

- Enlightenment on child's rights issues was carried out in major public and commercial places in Ibadan in the year through mass distribution of Information, Education and Communication materials. These IEC materials were distributed during key project activities. The School Based Children Groups, stakeholders and organizations working in the area of child protection were given the IEC materials. The distribution of the IEC materials was effective in sensitizing the public on the ills and forms of child trafficking, labour and violence.
- The social media platforms - WhatsApp, Twitter and Facebook - proved to be very
- Three (3) Orientation Workshops on Early Warning System for Stakeholders were conducted in the year 2020. The workshops helped to strengthen the intervention skills and knowledge of stakeholders on child's rights issues. Participants in the workshops included teachers, parents and children, law enforcement agents and other stakeholders from various sectors working on child's rights. The participants gained knowledge on early signs of child's rights violations and the procedures of reporting cases for appropriate interventions. Important contacts and phone numbers of key stakeholders, including the law enforcement

viable in the year 2020 for enlightenment as well as information sharing on the prevention of violence against children and women, especially during the Covid-19 lockdown and limitation of physical meetings. These social media platforms were used to disseminate information widely on children and women's rights in the Programme.

- Orientation Workshop was organised for teachers, parents, children and law enforcement agencies on Early Warning System to identify indicators and conduct a stakeholders' analysis to tackle the problem of child trafficking, labour and violence in the community.

agents were given to strengthen the communication channels to address the problem of child trafficking, labour and violence in Ibadan and environs.

PROTECTION OF CHILDS RIGHTS

The protection measure implemented by the Women Development and Child's Rights Programme in the year involved capacity building of stakeholders including children, parents, teachers, school counsellors, school principals, community groups (the Local Cluster Vanguard Groups), professional bodies, government ministries, social agencies, law enforcement agencies, etc.

- In addition to building the capacity of children for positive orientation on their rights through school visits and the weekly Child's Rights Club activities, three (3) schools were inducted into the In-School Influencer programme at St Patrick's Grammar School, Oba Akinyele Memorial High School and Loyola College, Ibadan on 20th March. This is to enable the children use their influence positively in furthering enlightenment of their peers on children's rights.
- Part payment of WAEC fee was provided to 41 indigent SS3 students on 24th January to enable them write their Secondary School Leaving Certificate Examination. Parents were encouraged and made to come with the balance of the WAEC fee on the picked date.
- Follow-up activities were carried out for the beneficiaries of the educational and vocational support provided to indigent children in the programme. The follow-up involved updating the records of the children on their educational/vocational attainment and giving them counsel on their education, trainings or vocations. Particular attention was given to the children being promoted from the primary school to the secondary school and those being promoted from the junior secondary level to the senior secondary. Fifteen (15) children submitted their promotional results in this regard and were counselled on their education. Similarly, there was follow-up on the 14 children who benefitted from the vocational support in the previous project. Eventually, in 2020, six (6) out of the 14 children supported in vocational trainings completed their trainings and started their own vocations, submitting copies of their graduation certificates while the remaining eight (8) are still in their various vocational trainings.
- Eighty households of indigent children were provided economic empowerment support. This involved entrepreneurial trainings and provisions of revolving grants to enable them improve on their economic activities. This in turn has been beneficial for the children within the households as the parents are empowered to take up the responsibilities towards the education and other needs of the children.
- Seventy-five children were provided educational support in June. Also, 52 children were given the educational support in July. A total of 127 indigent children thus benefitted from the provision of educational support in the Programme

during the year 2020. These 127 children are apart from the 373 children who were provided the educational support in the previous years of the project phase July 2018 – June 2020. On the whole, 500 indigent children comprising 265 males and 235 females who were victims of child trafficking, labour and violence in the 11 LGAs of Ibadan, Oyo State have been resettled back into a total of 171 schools (107 public secondary schools, 13 private

secondary schools, 43 public primary schools, and 8 private primary schools). The educational support packages given to the children include school fees, school levy, 2 pairs of school uniform, school bag, a pair of school shoes/sandals, school desk, 4 pairs of socks, 24 note books and writing materials and 3 text/course books per child.

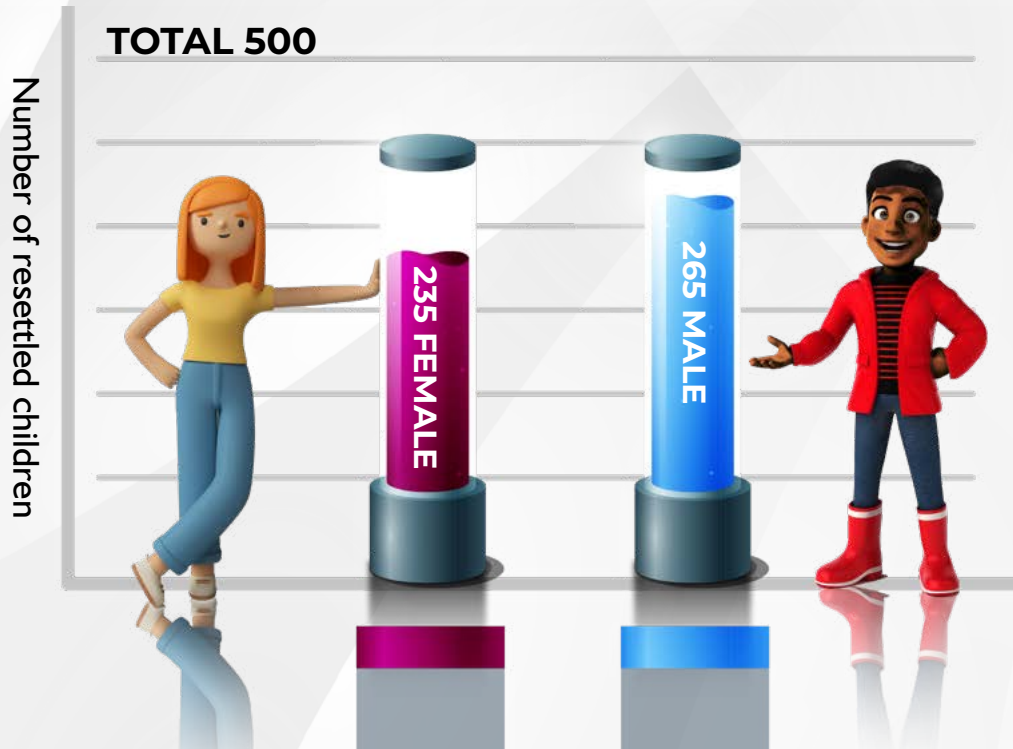


Figure 2: Analysis of the Educationally Resettled children according to the more prevalent sex shows that 265 males were given Educational Resettlement while 235 were female.

- The Women Development and Child's Rights Programme conducted the Annual Stakeholders' Conference on Child Trafficking, Labour and Violence on the 25th and 26th of June, 2020. The Conference provided opportunities for participants to be enlightened on trends of child trafficking, labour and violence. Stakeholders also discussed challenges and way forward on issues related to child trafficking, labour and violence in Oyo State.
- Training on Trauma Sensitivity was conducted online (WhatsApp) for the coordinators of the School Based Child's Rights Clubs on 14th May, 2020. The coordinators developed capacity on the meaning of trauma, why it matters to professionals working with children and providing informed care for the children.
- trafficking, labour and violence and female genital mutilation.
- In the year 2020, there were 17 media coverages including; 3 television coverages, 3 radio coverages, 2 print media coverages and 9 coverages by online media houses. WDP officers also featured in 12 media programmes on child's rights issues. Three programmes were on television and 9 on radio about children and women's rights/development.
- Some of the media houses which partnered with the programme on public enlightenment include Radio Nigeria, Immaculate Online Television, Nigeria Tribune, News Nigeria, The Nation Online, National Insight, Fresh FM, Inspiration FM, Broadcasting Corporation of Oyo State (BCOS), 32 FM, Impact Business Radio, Oluyole FM, Premier 93.5 FM.

MEDIA AND PUBLICITY

Media strategies which involved media coverages (on television, radio and the print) for key project activities, featuring of programme officers in both television and radio programmes with focus on child's rights issues and development of women and online television/radio representations were helpful in the enlightenment of the public on child's rights issues including child

REHABILITATION

- The Women Development and Child's Rights Programme continually carried out casework interventions for affected children and vulnerable women in the year 2020. To this effect, nine (9) cases which involved 15 children ranging from child trafficking, sexual molestation, child neglect, severe beating to other forms of

child abuse were carried out. Also, cases of domestic violence and need for child custody etc., affecting five (5) women were carried out. The cases were handled in collaboration with other stakeholders in the state including the law enforcement agencies, the Network for the Defence of Child's Rights, relevant government ministries e.g., Ministry of Women Affairs, Ministry of Justice, Ministry of Education, etc.

NETWORKING

- Participated in the Training and Retreat organized by JDPC Ibadan between 9th and 15th January. Programme officers gained insights in the area of Critical Thinking, Creativity and Innovation, Monitoring and Evaluation, Creative Problem Solving Skills and The Catholic Social Teachings.
- Participated in the meeting organized by Child Protection Network (CPN) on 13th February. An advocacy visit was made to Hon. Bimbo Oladeji of the Oyo State House of Assembly in company of members of CPN. She promised to sponsor 2 bills on Sexual Abuse and also promised to work on Oyo State Child Protection Policy.
- Gave palliative support to some

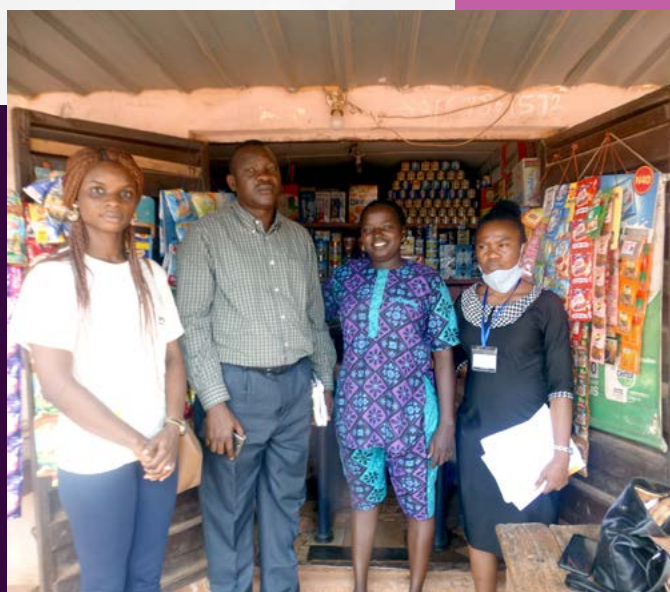
beneficiaries during the Covid 19 lockdown with support from Gift Rete Foundation on 16th and 22nd April, respectively. Twenty households were given one carton of noodles each as palliative support. The beneficiaries were grateful and thanked JDPC Ibadan.

- Stakeholders' Roundtable Forum on Peace and Security held on 21 September in collaboration with the International Peace Day Commemoration Planning Committee of Coalition of Civil Society on Community Peace.
- Participated in the official inauguration of the Family Court in Ibadan, Oyo State on 9th July. Justice, Development and Peace Commission, Ibadan carried out important roles in the establishment of the Family Court through our project activities which notably include advocacy visits and the Annual Stakeholders' Conference on Child's Rights. The Family Court is relevant to child's rights in the state to respond to cases of abuse against children and to handle cases of children custody, child neglect and children in conflict with the law. The main purpose of the Family Court is to enforce the rights of children.

PROTECTION OF WOMEN'S RIGHTS

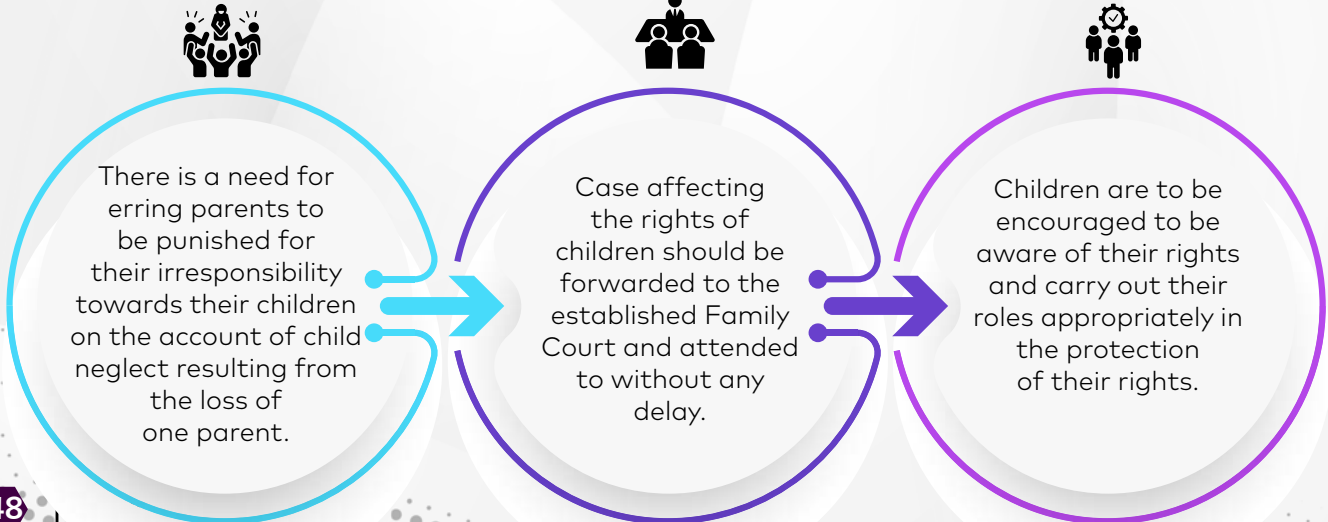
- Facilitated update training on FGM (female genital mutilation) to celebrate International Day of Zero Tolerance for FGM 2020. Twenty-one participants (20 females and 1 male) that include Community Health Workers, Public Health Worker and Nursing Officers were trained and updated on the dangers of FGM. They gave reports of happenings and indicators within their Primary Health Centres and provided likely solutions to the problems of FGM.
- Framework for reporting Female Genital Mutilation cases was formed.
- Counselling for victims of domestic violence and women who were susceptible to being trafficked.

- Failure of government to circulate and adequately implement the content of Child's Rights Law of Oyo State 2006.
- Family instability leading to existing gaps between parents and children has been a major reason why many children are being exposed to trafficking, labour and violence.
- Carefree attitude on the part of the parent towards educational resettlement support which causes their children to miss out of the intervention opportunities poses a great challenge to tackling CTL. Parents need to be enlightened on the need to take their children's future serious.
- Unwillingness of some parents to desist from the practice of FGM based on certain cultural/religious tenets is a great challenge to the total stop of the practice. More enlightenment is required for the concerned people as regards the protection of the dignity of women and girls.
- Lack of funds makes it difficult to take campaign against FGM to rural areas where the information is needed the most. More funds will enable the establishment of more FGM counselling desks in PHCs.

CHALLENGES

- Unavailability of government-owned homes for temporary shelter and rehabilitation/correctional purposes.
- Low level of commitment, responsibility, literacy and increasing rate of poverty pose a great challenge in the fight against child trafficking, labour and violence as parents leverage on this to violate the rights of their children.

Introduction

Caritas programmes began in earnest in the year 2020 and kept alive the vision of Justice Development and Peace Commission Ibadan Archdiocese. The promotion of the dignity of everyone encountered defined our activities and the strategies adopted. In spite of the COVID 19 challenges, we left no stone unturned in reaching the people of God most especially our brothers and sisters in Agodi Custodial Centre.

We attended to some of the numerous needs of the Agodi inmates. We equally solicited for financial and material support for the indigent persons. This, we were able to meet with some of the needs of the indigent person who visit JDPC Office frequently with high hopes that they would find listening ears. The Justice Development and Peace Committee in Parish (JDPC-P) to some extent helped to bring our vision closer to the people of God within and around some of the parishes of Ibadan Archdiocese. The message of peace reached the people of God, especially people at the grass root through seminars and talks on peaceful coexistence conducted at schools, parishes and some organizations.

Programme Goal

That all may realize and appreciate the image of God in them and thus live positively, spread the positivity around and bring about the promotion of the kingdom of God.



Strategies



1. AGODI INMATES GENERAL WELFARE

The general welfare of the inmates at the Agodi Custodial Centre took a different turn this year because of the COVID 19 pandemic. We had direct interactions with and counseling of the inmates from January until third week of March 2020 before the Nigeria Correctional Services' authority placed a strict restrictive measures at the Custodial Center. Visitors including religious people were prevented from entering the custodial Centre.

The restriction halted most of our activities with the inmates; however, we did not relent. We continued with the care of the inmates

and were able to reach them through the Agodi Deputy Controller of Correctional Service (DCCS), the Agodi Custodial Welfare staff and two inmates who represented the other inmates.

The number of the inmates in Agodi reduced from 1,200 to less than 1,000 in the course of the year in view of the COVID 19 call for Custodial Centre's decongestion. The release of some of the inmates with minor offenses, though a good move, did not make much difference. The reduction appeared insignificant given the extent of overcrowding in the custodial Centre that has only the average capacity of 390.

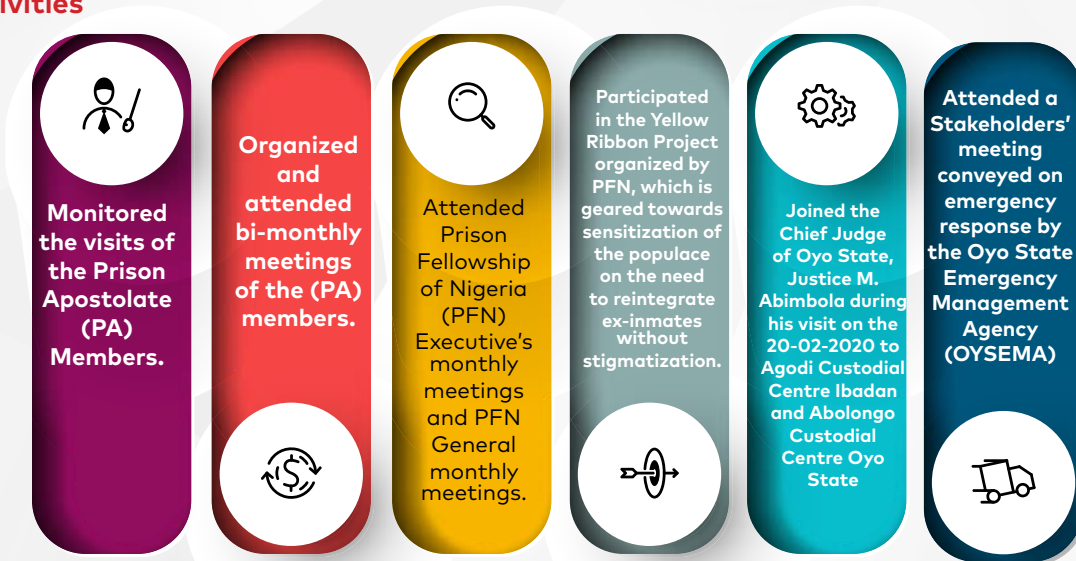


2. NETWORKING AND COLLABORATION WITH OTHER GROUPS

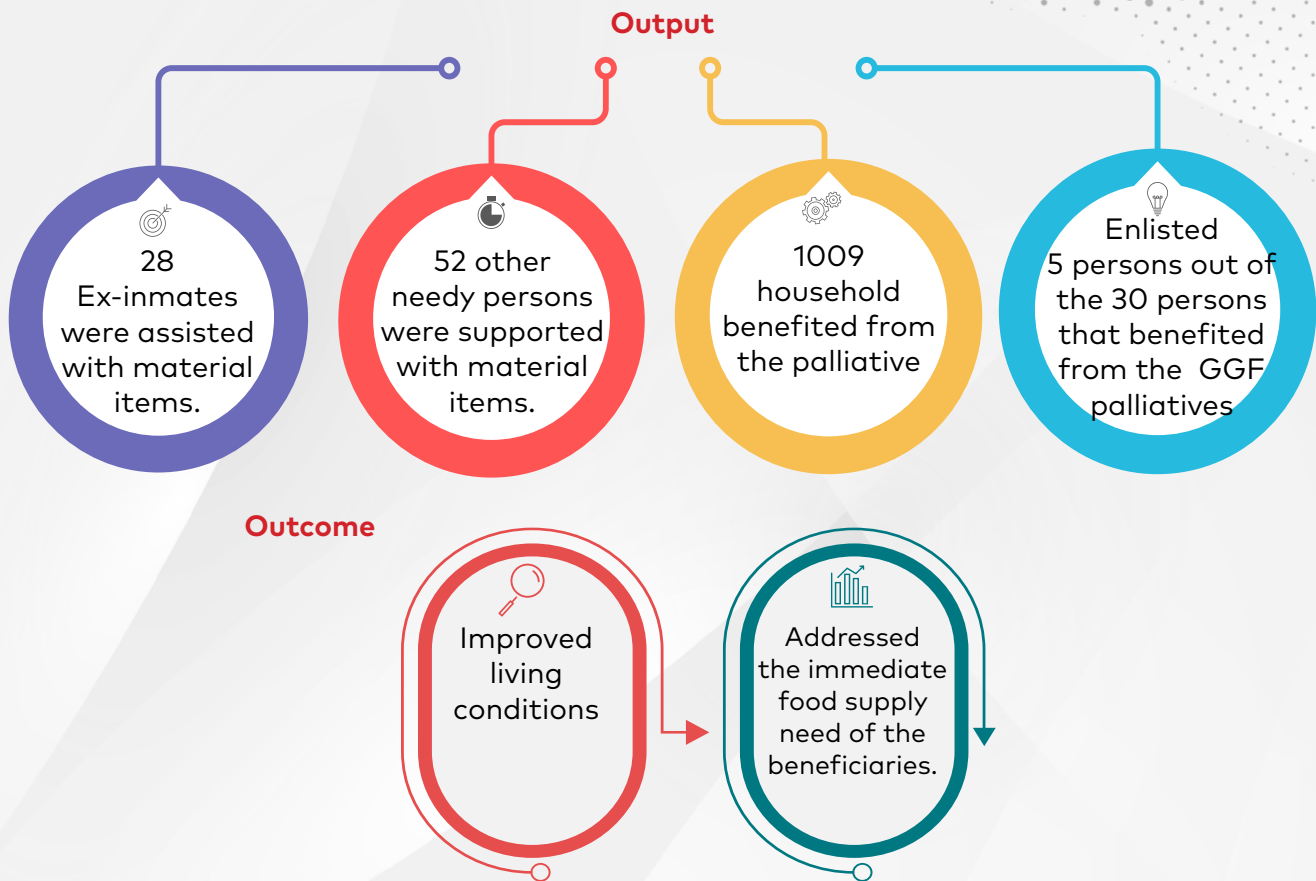

- The JDPC-P promoters at Good Shepherd Parish, Felele, assisted an Ex-convict to gain employment through his pastor

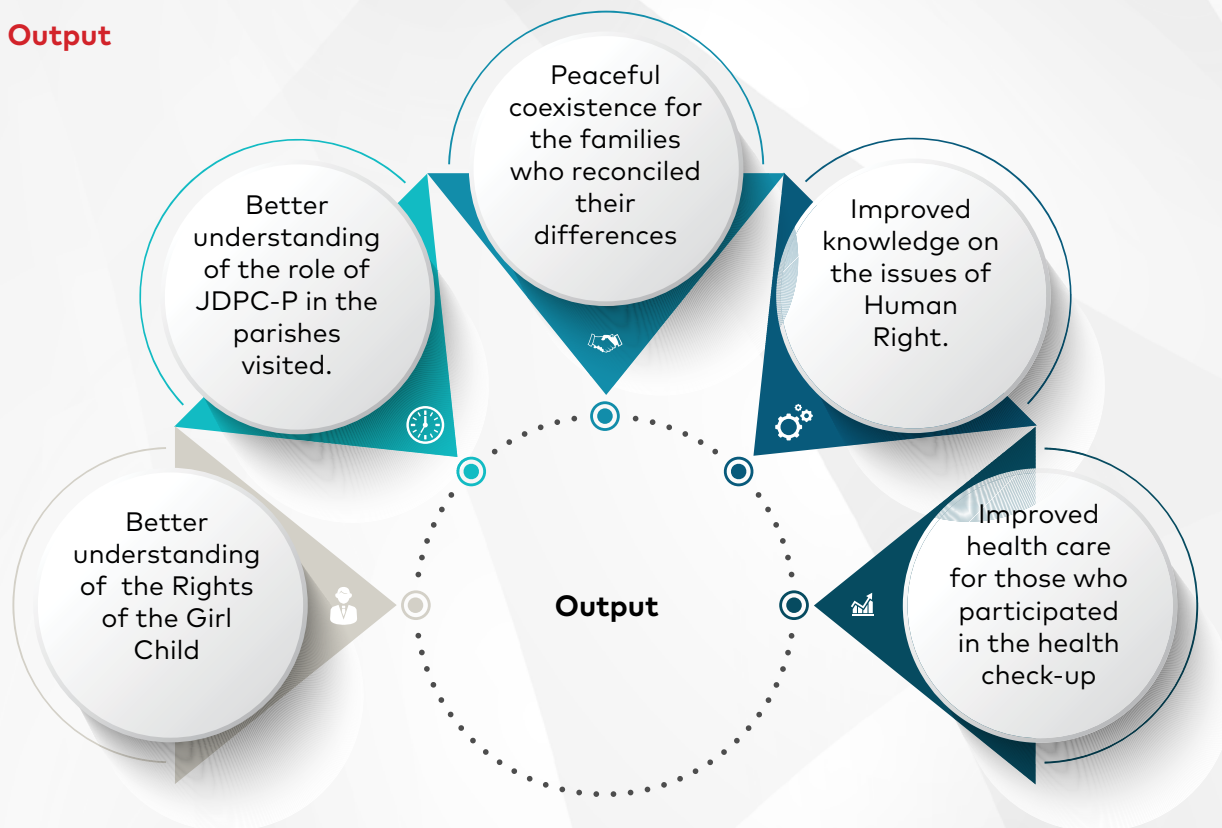

OTHER MILE STONES ACHIEVED

1. Need Assessment Research on Human Trafficking.

According to report by the Director General of NAPTIP, Dame Julie Okah-Donli at the inauguration of the Oyo State Task Force on

Human Trafficking, NAPTIP has reduced 1,052 (782 females and 270 males) victims of Human trafficking who are indigenes of Oyo State between 2004 to July 2020. Similarly, the International Organization of Migration (IOM) repatriated 716 victims of human trafficking between 2017 and 2020. The report is scary, a confirmation of the

enormity of the issue at hand and could just be a tip of the iceberg. The aforementioned figures are for those rescued. You can imagine the number of those still hoping to be rescued.

In a bid to address the increasing cases of Human Trafficking across the local governments of Oyo State and beyond, we started a need assessment research on human Trafficking to assess the awareness level, perception and attitude of people on Human Trafficking in Oyo State. The purpose

of the assessment was to gather the right data on the issues of Human Trafficking, which will greatly inform our collective intervention measures in addressing the menace of Human Trafficking for the promotion of human dignity.

We adopted a mixed method research design, using questionnaire and unstructured interview guide instruments. The target population was individuals, agencies and institution within 11 Local governments in Oyo State.

Activities



Output

- Administered 600 questionnaires in 8 out of the 11 local governments. (320 questionnaires for individuals and 280 for agencies and institutions).The Local Government Areas covered are: North East, Oluyele, Lagelu, Ona Ara Ogbumoso, Atisba, Saki west.

2. The 2020 annual christmas party for the Agodi Custodial inmates took place on 24th December 2020.

We strictly observed the COVID 19 guidelines during the party beginning from the shopping, preparation, packaging of food, Eucharistic celebration to the distribution of food to the inmates and staff.

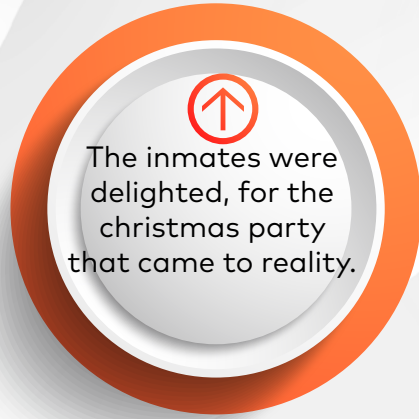

- For some Security reasons, we were unable to administer the Human Trafficking questionnaires in three Local governments Areas, Saki West and Ogbomoso North.

The work of God continued in spite of the enormous challenges of the year 2020. We emerged better and more connected irrespective of our race, class or colour. We appreciate all our network groups and individuals who helped us make the Charity of Christ palpable for the people of God.

COMMUNITY SERVICE PROGRAM

COMMUNITY SERVICE PROGRAMME

Background

The Community Service punishment scheme of Oyo State was birthed out of the need to establish a better and more effective criminal justice system in Oyo State as well as to contribute to decongestion of Prisons (Now known as correctional centers) in the state. JDPC Ibadan took it upon itself to ensure that community service punishment is given consideration as an alternative to imprisonment for minor offences in Oyo State.

The purpose of the community service program of JDPC Ibadan is to promote community service as an alternative form of punishment for minor offences as opposed to incarceration.

The community service project of JDPC Ibadan has undergone various stages before getting to its current phase; with MISEREOR being its major funding donor. the first two phases of the project focused on policy advocacy and lobby with the goal of getting the community service punishment bill passed into law; which was finally achieved in 2016.

The program is currently at the tail end of its third phase which is focused on implementation, management and administration of the community service punishment Law and scheme in the State.

The community service program team of JDPC Ibadan currently works in collaboration with the Oyo State Judiciary which is the major implementer of the Law.

Project Goal

To contribute towards improving the efficiency, effectiveness and humaneness of Nigeria's criminal Justice system.

Project Objectives

At the end of the project period, all 43 magistrates and Presidents of Grade 'A' customary courts apply community service punishment instead of custodial sentences on simple offences.

Set up an effective information system for monitoring and tracking of serving offenders.

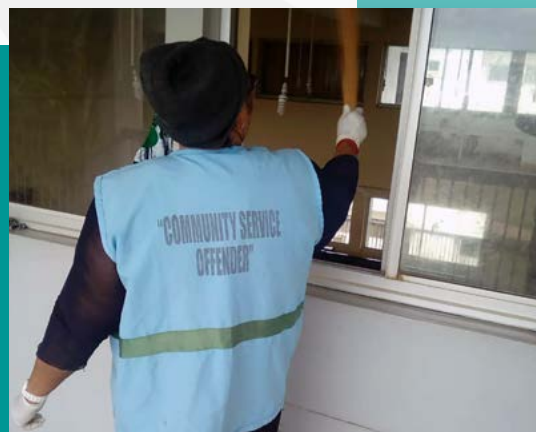
Highlights of activities between January and December 2020

It is no news that 2020 has been a unique and very different year. As a result of the outbreak of Covid-19 pandemic, a lot of program activities were disrupted however, upon the ease of the lockdown, some activities were carried out albeit observing strict covid-19 protocols.

- Advocacy actions with Counseling Association of Nigeria (CASSON) for inclusion in the community service scheme.
- Joint monitoring visit with the judiciary to all community service units in the state.
- Regular monitoring and assessment of community service units and community service centre (central registry).
- Regular assessment of reactions of offenders participating in the scheme as well as that of community members who have had first-hand experience with the scheme. This is done through oral interviews and administration of questionnaires.
- Regular collection and collation of Community Service sentencing data from the Oyo State Community Service Centre.
- Regular monitoring & data gathering visits to Agodi and Abolongo Correctional centres; to retrieve data of awaiting trial inmates sentenced to community service from the Custodial Centre and offenders who have been sentenced to community service but carried out their community service sentence in the centre due to one reason or the other.

- Prison Visit and special court session with the with the Honorable Chief Judge.

Key Achievements of the scheme in 2020

A lot of sectors including the judiciary were relatively crippled and affected by the global pandemic. In the heat of the pandemic, courts did not sit and even the correctional services did not admit new inmates. Many offenders were remanded in police custody while some others settled out of court. This led to a drastic decrease in the number of offenders sentenced to community service punishment.

However, it is noteworthy, that upon re-opening of courts, trials were conducted remotely. This led to the Honourable Chief Judge issuing a directive that only community service punishment should be meted out to defendants whose trials were concluded within the period. This is a welcome development as this indicates that the option of community service became the only practical form of punishment during this novel period as against the previous norm of incarceration.

This goes to show that the scheme has gained a lot of ground and recognition in the State and it has come to stay.

Also in the course of the year, the CSP team of JDPC Ibadan facilitated the signing of MoU between the judiciary and CASSON. The MoU establishes a relationship between both parties and enables CASSON to conduct counselling sessions for offenders who carry out community service. This is to ensure proper rehabilitation of offenders who pass through the scheme.

The efforts of JDPC Ibadan in the promotion of non-custodial forms of punishment in Oyo State has not gone unnoticed. This year, the CSP team was co-opted to be a member of the Non-Custodial sentencing committee of Oyo State. The committee which was constituted by the executive governor of Oyo State through the office of the Attorney General & Commissioner for Justice consists of stakeholders who are involved in the promotion of non-custodial sentencing in the State. The major assignment of the committee is to brainstorm and come up with a comprehensive Non-Custodial

Sentencing law of Oyo State which would incorporate community service and other forms of non-custodial punishments and create a bigger and better structure for non-custodial punishment in Oyo State.

The project was evaluated this year and it was observed that So far, the project has been able to achieve its set objectives. The project commenced with forty-three (43) magistrates and of all the forty-three, thirty-six (36) of them have applied community service as an alternative to imprisonment for minor offences at one time or the other from the commencement of the project in 2018 till date.

Despite the pandemic, Between **January and November 2020, ninety (90)** offenders of minor offences were sentenced to community service across all the magisterial districts in the state. As such, a **total number of three hundred and ninety-four (394)** offenders of minor offences have been sentenced to community service across all the magisterial districts in the state since the commencement of this phase in January 2018.

Challenges

It is commendable that the community service punishment scheme has stakeholders who are highly supportive. However, one major challenge faced by the scheme is inadequate funding and lack of budgetary allocation from the government. It is our hope that with vigorous advocacy, this challenge would be resolved in the nearest future.

COVID-19 FOOD RELIEF PROGRAMME

By the end of March, 2020, the COVID-19 Pandemic had become a reality in Oyo State. To contain the virus and curtail its spread, the Government imposed a lockdown, putting a stop to most economic and social activities. This situation within a matter of days took its toll on the people; food became very expensive and with their financial activities crippled, hunger became a greater threat to life than the pandemic.

In a bid to cushion the effect of Covid-19 Pandemic on the residents of Oyo State, JDPC, Ibadan sought the support of its partners: Corteva Agri science, a company completely dedicated to agriculture and committed to enhancing lives made a donation for the provision of 120 packs of foodstuffs to be distributed to farming households. Givefood.ng, an emergency food relief platform formed by a coalition of leading public and private partners

raised funds from individuals and corporate organizations and financed the provision of palliative food packs for another 110 households. The German Catholic Bishops' Organization for Development Cooperation also known as MISEREOR who has been committed to fighting poverty in Africa, Asia and Latin America for over 60 years and has been supporting our interventions for the past two decades funded the provision of food palliatives to One thousand and nine (1009) Vulnerable Households.

With the support of these partners to whom we are immensely grateful, over one thousand three hundred households from Ibadan North, Ibadan North/East, Ibadan South/East, Ibadan South/West, Ona-Ara, Akinyele, Lagelu, Iddo, Ibarapa, Egbeda and Oluyole local government areas were reached.

Basis of opinion



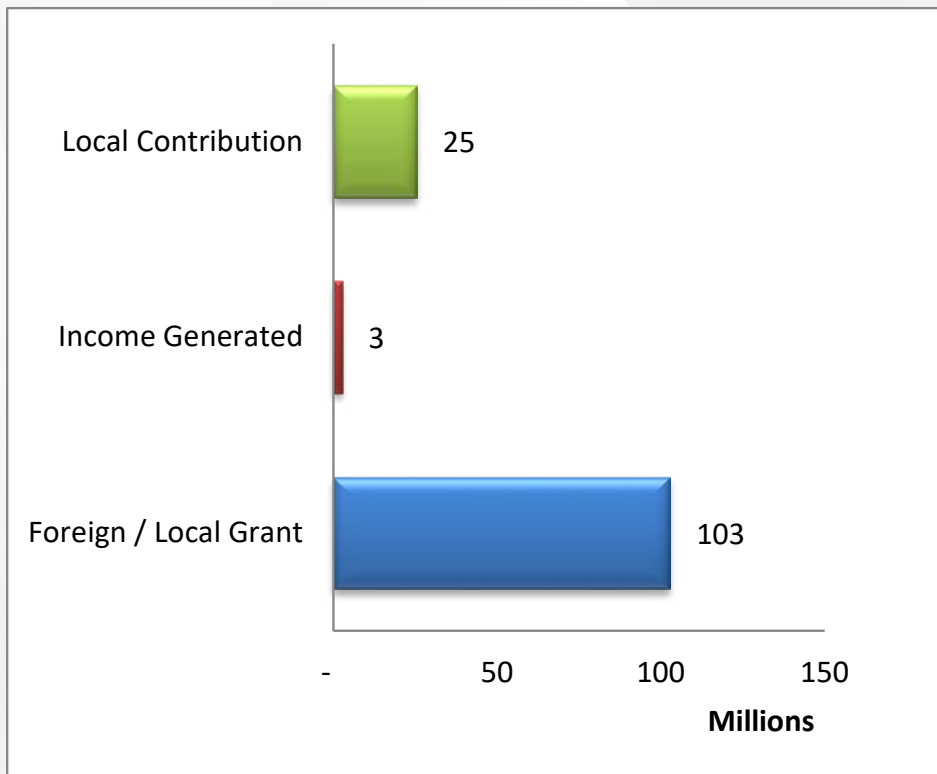
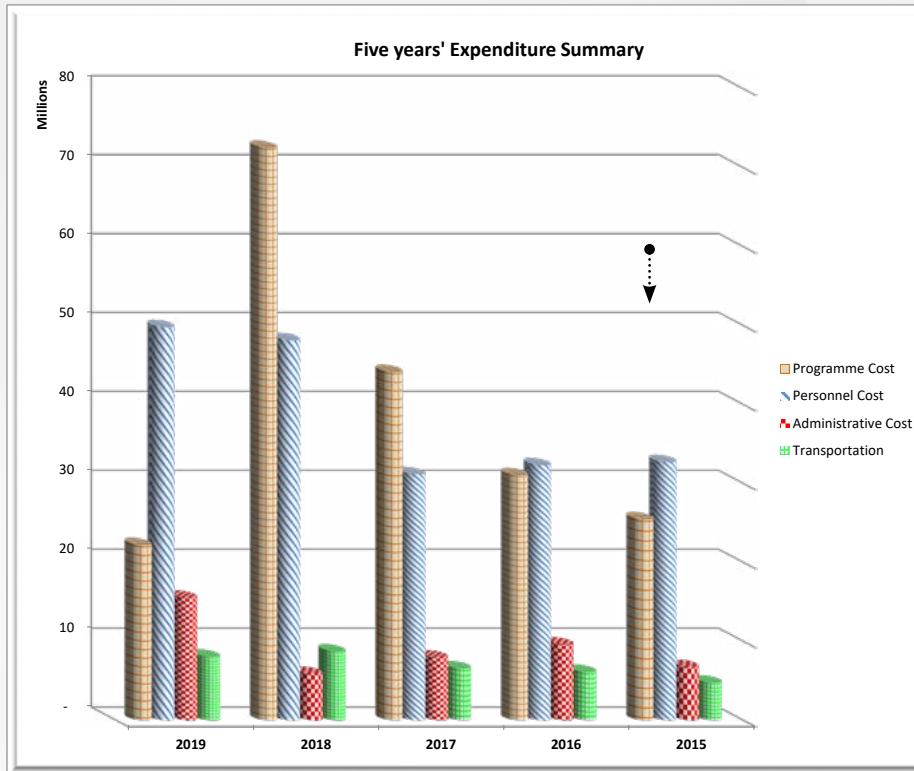
A Chart Showing Income Pattern in 2020

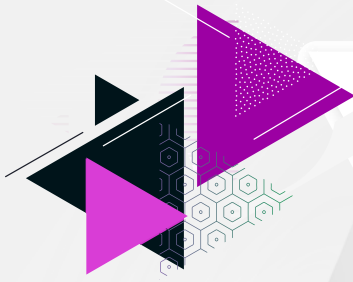




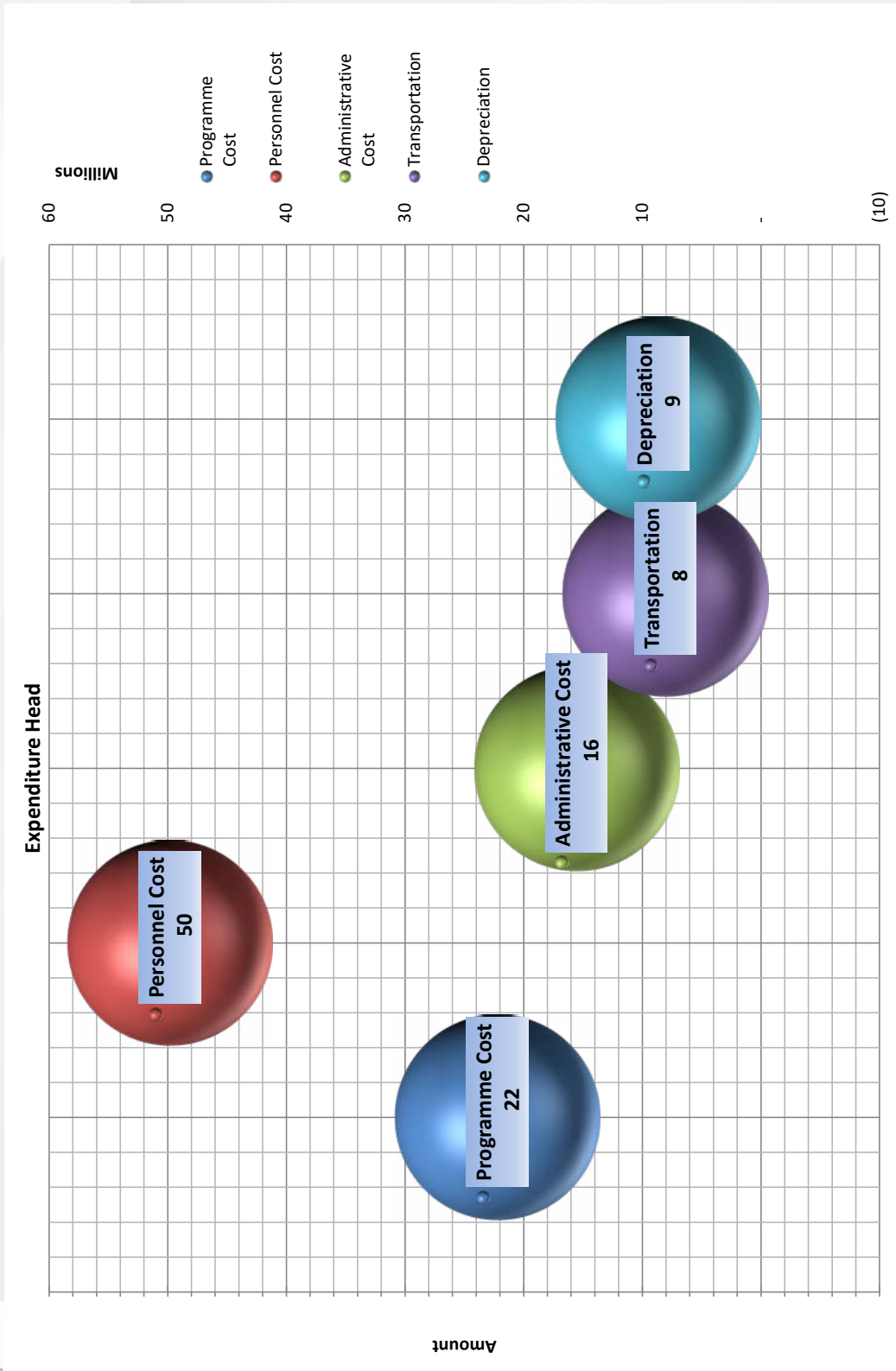
